1. Purpose of the Reform Initiative

Support Mechanism

Reform of digital support of government include implementation of electronic system documentation in government institutions and developing and deploying Cloud and Hybrid architectures and infrastructure for software applications.

System of electronic documentation (SED) was created by initiative employers of PAU in 2014. The goal was to develop an electronic system that would combine essential in daily operation work of each government employer. Basic principals: transparency and speed in the process, usage of electronic signature, controlling of all status of documentation and analyze of work of government employer. SED was launched in February 2015. Due to the increase of request about SED from government institutions, in march 2016 PAU presented SED for all government institutions and from June 2016 closed legal issues about SED delivery to other government institutions.

On August 15 2016 the Cabinet of Ministers completely switched to electronic documents, that again demonstrates the readiness of government to create digital communication platform for all government institutions. SED implementation is the one of reform that is transformed into projects, that is critically depends on staff skills and effectiveness.

The goal of the reform initiative is to provide digital support to the GOU and implement system of electronic documentation (SED) by building GOU action plans monitoring platforms and extending SED to more governmental institutions. It will facilitate the sustainability of several government institution reform e.g. anticorruption and public administration through the modern management approach, as well as foster better management and monitoring of the governmental actions plans implementation e.x. 2016 GoU Action Plan, Eurintegration and others.

The team will introduce modern approach for complex projects management and conduct intensive training, supporting, guidelines and consultancy session for government employers in Ministries, regional and other government institutions, building automatic systems will introduce modern approach for creating electronic system and consultancy sessions for employees from ministries of the GOU.

Scope of Work

- Coordination between all involved parties (clients, developers, partners, donors)
- Presentation, preparation of materials, preparation pf interview, press-releases.
- Consultancy session for SED implementation
- Weekly meeting with partners, clients, developers, project team

2. Technical Experts:

- Conduct consulting sessions and trainings for public servants
- Support Team lead in implementing SED in 2 Ministries and 8 Governmental Institutions
- Build electronic system to fill out and managing tasks
- Facilitate retrospective meetings for project team weekly
- Create analytic reports tool
- Build public site for everyone to show tasks progress of implementation activity plan from the Cabinet of Ministers of Ukrain
- Create support and user documentations
- Implementation of program for monitoring of action plan of reforms.

3. Qualifications and Experience

The incumbent is expected to have the following qualifications:

- Experience in providing technical advice and consultancy to clients and management on matters of technical architecture infrastructure developments, including their feasibility, developing SharePoint Solutions, meeting customers face to face.
- Skills in technical document preparation by using MSF, solution deployment and implementation, working closely with customers, Q&A, Hybrid and cloud solution deployment, office 365 solutions development, etc.
