Position Summary: Based in EDGE's Kyiv National Office and reporting to the Field Director. Sector Lead/Legal Expert will be responsible for research, analysis and advise to the EDGE's team on Ukrainian legislation in relation to TA initiatives undertaken. In close collaboration with the Field Director and technical teams, the Legal expert will analyze gaps in existing legislation and elaborate recommendations to support development of relevant national legislation and ensure sustainability of EDGE's TA initiatives in the areas of Governance, Transparency and Efficiency & Economic Growth. The Sector Lead/Legal Expert will perform project management duties and will be the principal liaison between the project and the relevant government beneficiary.

 - Draft gaps analysis and recommendations sections contributing to strategies and policies developed by technical teams in cooperation with governmental partners;

 - Facilitate the work through liaison with Ukrainian government and local level stakeholders, work groups and experts committees with regard to development of relevant legislation and policies;
